## Rules and Regulations for Nursing Colleges

1. I card and college uniform is mandatory for all students and tutors who are coming.  
(Female tutor is mandatory for girl's students. )
2. Food charges: Rs 5000/- per person per month.  
(Please note: This is valid only for those students/ tutor who will be residing at the setup. Food Includes Breakfast, Lunch, Dinner & Twice tea)
3. Residential charges: 1500/- per month.(Per student/Tutor) For 15<sup>th</sup> days 900Rs
4. **The residential facility is like a dormitory.**
5. Before booking you have to visit centre to see the residential facilities.
6. The food charges and residential charges are mandatory for Supervisors/teachers accompanying the batches.
7. Student clinical fees: 2000/- per month. (Per student) For 15<sup>th</sup> days 1200Rs.  
Please note: Above mentioned charges would vary (increase/decrease) as per duration of the Stay of The students.  
If posting would be for more than a month charges would vary.
8. If you need examiner from Nityanand, you have to inform us one week in advance.
9. The examiner and tutor charges are Rs. 2000/- and need to be paid before the examination is going to be conducted.
10. Routine schedule for students would be given once the students are here.
11. Students are expected to do their posting at our Pachanegaon setup. You can have a look at it at our website.[www.nityanandrehab.com](http://www.nityanandrehab.com)  
Residential facility is available at Pachanegaon centre only.
12. You will have to confirm your month of posting; you are expected to pay a 50 % deposit which is mandatory if in case of posting cancellation, deposit remain nonrefundable.
13. If you exchange the month of posting, you have to repay the deposit.  
(Deposit: You will have to pay half the amount of Residential and Students fees as for total Number of students.)  
Please note: Booking for chosen time period is done only if payment is done in advance  
Remaining charges i.e.: Residential, Food & Students fees will have to be paid

### Do's and Don'ts for Nursing students

- Mask and sanitizers are compulsory for all, hospital will not provide anything from this things.
- You have to carry your own bed sheets.
- Handle patients with love, care and sanity.
- Maintain appropriate distance from the patients.
- Keep record of patients' complaints.
- If anyone damage institutional property charges will apply.
- If you find any inappropriate objects with patients, inform the counselors.
- Do not delve into personal histories of patients. Collect the appropriate information from files.
- Maintain confidentiality.
- Patients who have excess clinging tendency, give a particular time to attend them and not otherwise.
- Avoid gossiping/ chatting with your colleagues/ patients anywhere in the hospital in the work time.
- Dress up formally at all the times when you are around the patients. Using short or exposing, provocative cloths is not allowed in premises.
- During working hours mobile phones are prohibited in the Institute premises.
- If any student is found using, carrying or obtaining any substances like tobacco, cigarette, alcohol etc. would be immediately forced to leave the premises of the Institute. He/ she will not be allowed to complete their internship. His college and instructor will be notified about such incidence. Also a fine of Rs.5000/- will be applied to each student participating in such activity.


